Payment Instructions for Tuition Fee and Hostel Fee Debit Notes (NO hardcopy debit notes will be sent by the University)

1. Please be informed that <u>ONLY</u> electronic debit notes for tuition fees and hostel fees will be issued in the University Cyber Port System (BUniPort). <u>No hard copy of debit notes will</u> be sent.

2. **e-Debit Notes**

Students can access the e-Debit Note by:

- ➤ Login to BUniPort using your designated "SSOid" and "Password" to download the debit notes.
- Notification of e-Debit Notes will normally be sent to your University email account two weeks before the payment due dates. Please observe the below payment schedules and ensure debit notes are paid on time.

- For functions of BUniport, "Functions of BUniPort > My Finance".

4. Payment Deferral

- ➤ Only students awaiting the results of the Government Grant/Loan, NLSFT or ENLS Loan may apply for <u>deferral of tuition fee payment</u>.
- ➤ NO deferral will be granted merely for students being at overseas (including Mainland China).
- Your deferral application must be submitted in BUniPort before the payment due date.
- ➤ Please read the "Notes for Application of Deferral of Tuition Fee Payment" before submitting your application.

5. Overdue Payments

- ➤ A fixed overdue penalty of \$500 will be charged if you fail to settle or successfully apply for payment deferral before due date.
- > Students who fail to settle the outstanding tuition fees within 10 working days from the due date/deferred due date shall be considered as unofficially withdrawn from study.
