

RESEARCH COMMITTEE

Terms of Reference

- (a) To develop, monitor and review policies relating to the University's research activities, including research project, research funding, research ethics, research infrastructure, research impact, and research training, internationalisation, and their management, and to provide advice and recommendations to the Senate on related matters as appropriate.
- (b) To develop and administer policies, procedures and strategies that will promote University research clusters/Faculty niche research areas, transdisciplinary and collaborative research at different levels.
- (c) To provide advice on mechanisms to improve monitoring, benchmarking and reporting of the University's research performance.
- (d) To oversee internal and external reviews of the University's research activities, and monitor the progress of internally- or externally-funded research projects.
- (e) To determine the allocation of resources for research, including internal research funding, research infrastructure and research postgraduate student places.
- (f) To review and deliberate on the research postgraduate programme offerings and recommendations from the Research Postgraduate Studies Committee for submission to the Senate as appropriate.
- (g) To set up and appoint members to task-based working groups or task forces to review various applications and follow up on specific matters that may arise from time to time.
- (h) To guide, monitor, review and endorse as appropriate the activities of, and comment on the reports received from its sub-committees, including the Central Research Facilities Sub-committee, the Research Ethics Committee, the Research Ethics Committee at the Institute for Research and Continuing Education, and the Research Postgraduate Studies Committee for submission to the Senate as appropriate.
- (i) To submit an annual report to the Senate as appropriate.
